  - o Motions:
    - If a vote is required, a motion must be made and seconded prior to the vote. Normally, the President states the question (describes the proposed action) for consideration. The President then asks who wants to move and that board member states "I move" (and sometimes restates the motion). The President asks who wants to second the motion and that board member states "I second the motion." The motion carries if a quorum of 2/3 of the Board votes yes.
